## 1. DEFINITIONS

## 2. GRANT OF FRANCHISE

1. The Franchisor hereby grants the Franchisee the right to operate a food restaurant using the system, marks, and confidential business information of the Franchisor, in the designated Territory for a term of  years.

## 3. FRANCHISE FEES

1. Initial Franchise Fee:  USD, payable upon signing of this Agreement.
